Guidelines for Applicants and Sponsors

Full Membership Guidelines:

- (1) Must be over the age of 18
- (2) Must be of Italian descent OR married to someone of Italian descent
- (3) Must be "sponsored" by TWO Full Members
- (4) Acknowledges that the 1st year of membership is probationary
- (5) Must be sworn-in before being able to receive membership benefits
- (6) Willing to pledge to obey all the laws and rules of the Venetian Club, as they exist today, or may be revised to in the future

Social Membership Guidelines:

- (1) Must be over the age of 21
- (2) Must be "sponsored" by TWO Full Members
- (3) Acknowledges that the 1st year of membership is probationary
- (4) Must be sworn-in before being able to receive membership benefits
- (5) Willing to pledge to obey all the laws and rules of the Venetian Club, as they exist today, or may be revised to in the future

Sponsor Guidelines:

- (1) Must be a Full Member for at least ONE year
- (2) ONE of the sponsors must sign an affidavit on behalf of the applicant**
** The affidavit sponsor MUST attend the General Assembly meeting when the applicant's membership is up for review, in order to answer any questions regarding the applicant that the General Assembly or Board of Directions may have **

Application Process:

- (1) Applications are reviewed by the Board of Directors on a monthly basis
** If approved, a financial secretary will notify the sponsor of the General Assembly meeting date **
- (2) Accepted applications are presented to the General Assembly on a quarterly basis
- (3) If approved by the General Assembly, the applicant MUST attend a Board of Directors meeting to be sworn-in and to collect their membership card and key fob

The Board of Directors and General Assembly have the right to accept or reject any application, as they deem fit, without any retribution.

Sponsor Affidavit

Policy & Procedure

- This sponsorship affidavit must accompany the membership application for the individual you are agreeing to assist during their first probationary year of membership.
- By signing this affidavit, you are acknowledging you understand your responsibilities of assisting the applicant during the application process (as follows below), as well as, guiding them through their first probationary year as a member of the Venetian Club.

Application Process:

- (1) Applications are reviewed by the Board of Directors on a monthly basis
- (2) Accepted applications are presented to the General Assembly on a quarterly basis
 - ** If approved, a financial secretary will notify the sponsor of the General Assembly meeting date. The affidavit sponsor **MUST** attend the General Assembly meeting when the applicant's membership is up for review, in order to answer any questions regarding the applicant that the General Assembly or Board of Directors may have. Failure of the affidavit sponsor to attend the meeting may result in the application being denied **
- (3) If approved by the General Assembly, the applicant **MUST** attend a Board of Directors meeting to be sworn-in and to collect their membership card and key fob
